

## PhD Econometrics Eligibility Criteria

- ✓ MPhil (Mathematics/Statistics/Economics /Econometrics/Computer Science/Economics and Finance) or relevant degree with at least 3 CGPA (First Division) from a recognized institution will be eligible to apply for admission.
- ✓ Applicants are selected on the basis of their performance in the admission test, interview, academic record, research publications, letters of recommendation and statement of purpose.
- ✓ Students without relevant backgrounds need to take additional courses (non-credit) to make up for the deficiency.
- ✓ The in-service applicants are required to submit the No Objection Certificate issued by their employers before the beginning of the academic session.

- ✔ BS (4-year) in Economics/Statistics/Mathematics or MA/MSc in Econometrics and Statistics/ Economics/Statistics/Mathematics.
- ✔ Minimum Grade and division will be followed as defined in PIDE rules.
- ✔ Applicants will be selected based on their performance in the admission test, interview, and academic record.
