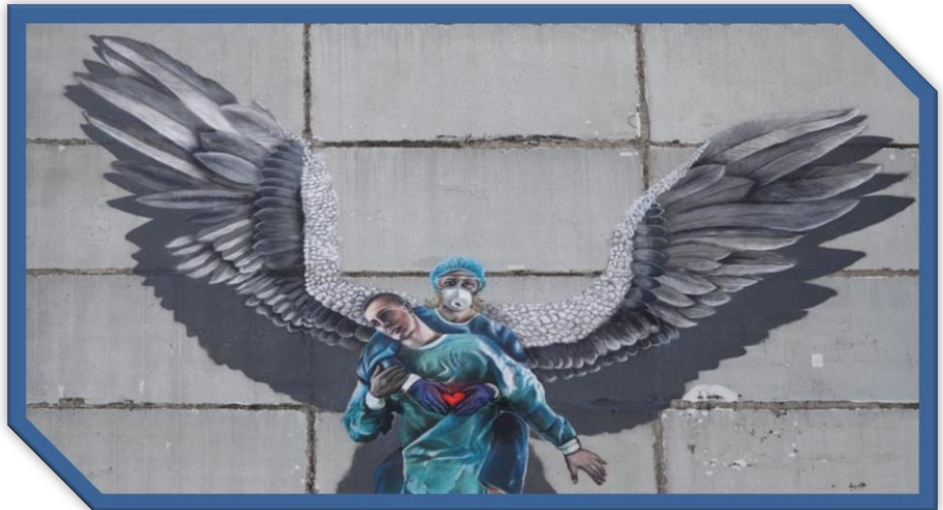

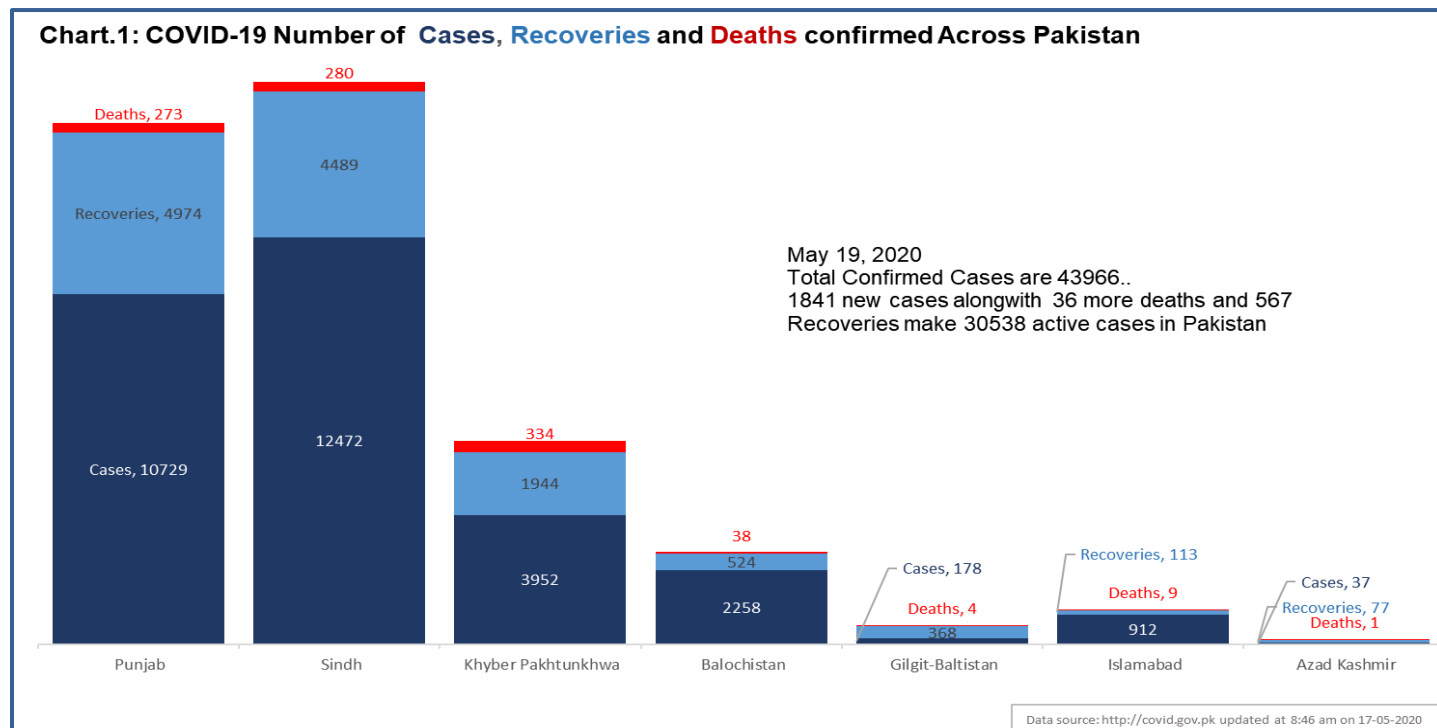

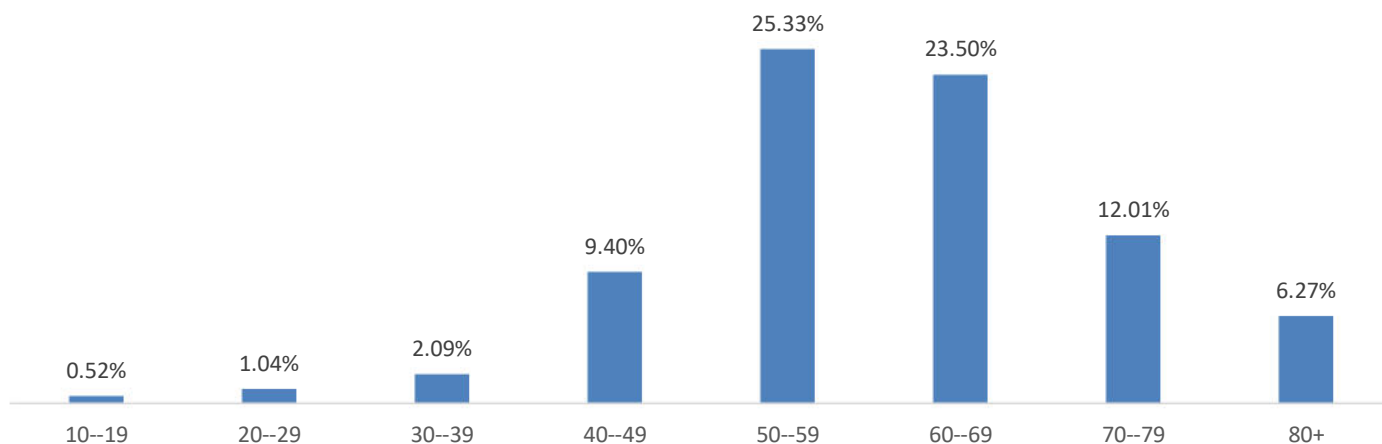

During the last 24 hours, 1841 new cases have been confirmed by different laboratories, bringing the national tally to 43966. Sixteen deaths from KP, thirteen from Punjab, three from Sindh and two from Balochistan have been reported in the last 24 hours. There are a total 939 deaths and 112489 recoveries across the country, see Chart.1.



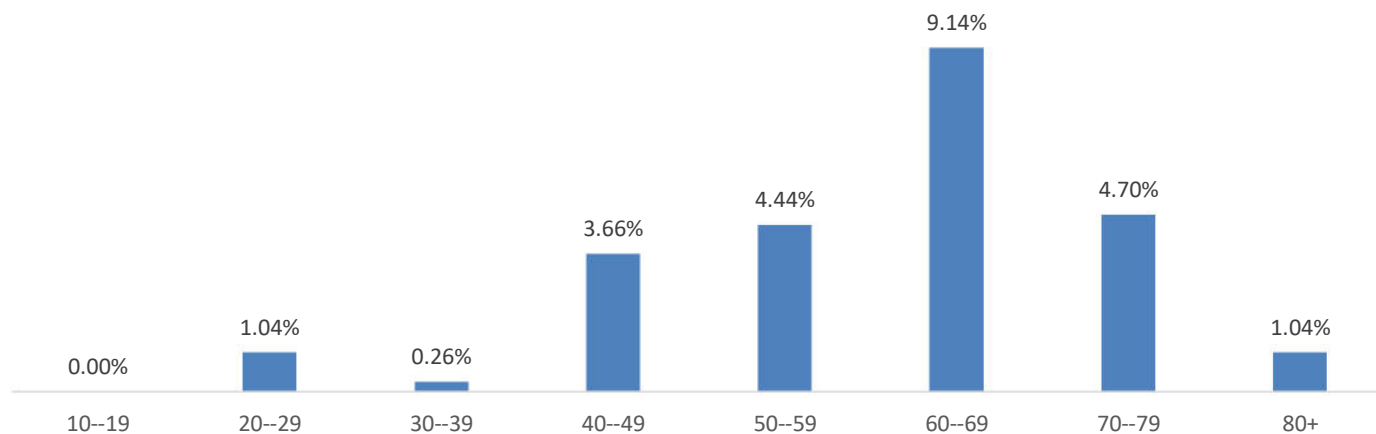
The age wise distribution of male deaths by COVID-19 reveals that age clusters 50-59 and 60-69 are more vulnerable than other age groups in male category, See Chart.2. About 50% male deaths by COVID-19 are reported in these two age groups combined together; less than 14% male deaths are reported in all age groups less than 50 years of age. The age-wise distribution of male deaths by COVID-19 is right skewed indicating lower immunity of elderly males against the pandemic. It is to note that younger male groups are more infected by the COVID-19, whereas lesser infected cases are observed from elder cohorts (ref: PIDE, NL No.36) but higher percentage of deaths are reported in elderly male groups. Still as of May 19, 2020, the spread of the Coronavirus (COVID-19) in Pakistan has hit mostly people less than 59 years of age. The deceased cases show different trajectory as it is more to do with the immunity of individuals. COVID-19 is contagious; in the absence of any medicine/vaccination social distancing is the only cure.

Chart.2: COVID-19 Age-wise Percentage of Male Deaths in Pakistan



The age wise distribution of Female deaths by COVID-19 reveals that age cluster 60-69 is most vulnerable than all other age groups in female category, See Chart.3. At highest 9% female deaths by COVID-19 are reported in this age group; none of the other age group crossed 5% deaths by COVID-19 in female category in Pakistan. The age-wise distribution of female deaths by COVID-19 is right skewed indicating lower immunity of elderly females against the pandemic. Just as the case in male category the younger female groups are more infected by the COVID-19, whereas lesser infected cases are observed from elder cohorts (ref: PIDE, NL No.36) but higher percentage of deaths are reported in elderly female groups. The female deaths percentages by COVID-19 are far below than male categories of same age; are women more immune against COVID-19 or they might be stricter to precautionary measures? The answer could be YES as it is observed in all type of diseases that female immunity is higher in general.

Frequently Asked Questions

Are public systems for disinfecting individuals such as spraying via tunnel or chambers safe to use?

No. Spraying of individuals with disinfectants (such as in a tunnel, cabinet, or chamber) is not recommended under any circumstances. This practice could be physically and psychologically harmful and would not reduce an infected person's ability to spread the virus through droplets or contact. Even if someone who is infected with COVID-19 goes through a disinfection tunnel or chamber, as soon as they start speaking, coughing or sneezing they can still spread the virus.

The toxic effect of spraying with chemicals such as chlorine on individuals can lead to eye and skin irritation, bronchospasm due to inhalation, and potentially gastrointestinal effects such as nausea and vomiting. In addition to health safety concerns, the use of chlorine in large-scale spraying practices may prevent this resource from being used for important interventions such as drinking water treatment and environmental disinfection of health care facilities.

Are gloves recommended for the community in public spaces to protect against COVID-19, for example when going to the grocery store supermarket?

No. The use of gloves by the public in public spaces is not a recommended or proven prevention measure. Wearing gloves in public spaces does not replace the need for hand hygiene, nor does it offer any additional measure of protection against the COVID-19 virus than hand hygiene. Gloves do not provide complete protection against hand contamination, as pathogens may gain access to the hands via small defects in gloves or by contamination of the hands during glove removal. People can also transfer pathogens from one surface to another by touching with gloved hands, or even transfer pathogens to the mouth, nose, or eyes if they touch their face with gloved hands.

How should I clean food items from the grocery store, for example fruit, vegetables or packaged items?

There is no evidence to date of viruses that cause respiratory illnesses being transmitted via food or food packaging. Coronaviruses cannot multiply in food; they need an animal or human host to multiply. The COVID-19 virus is generally thought to be spread from person to person through respiratory droplets. Currently, there is no evidence to support transmission of the COVID-19 virus associated with food.

COVID-19: Timeline of a Pandemic (March 24, 2020 — March 25, 2020)

March 24 — Cases of COVID-19 surpass 400,000. It took over three months to reach the first 100,000 confirmed cases, 12 days to reach 200,000, three days to reach 300,000, and two days to reach 400,000.

India's Prime Minister Narendra Modi announces a lockdown of 21 days for the country's 1.3 billion residents. This is the largest lockdown announced since the beginning of the outbreak.

The Chinese government announces it will lift the lockdown on Wuhan, the city at the center of the outbreak, on April 8.

An Asian Development Bank employee tests positive for COVID-19.

Libya and Laos report first cases of COVID-19.

March 25 — The United Nations launches a \$2 billion global humanitarian response plan appeal to assist vulnerable countries in fighting the COVID-19 pandemic. Funds would go to laboratory equipment, medical supplies, handwashing stations, public information campaigns, and the creation of air bridges and hubs in Africa, Asia, and Latin America to move humanitarian workers and supplies.

"COVID-19 is menacing the whole of humanity — and so the whole of humanity must fight back. Individual country responses are not going to be enough," says U.N. Secretary-General António Guterres when announcing the appeal.

During a press conference, Tedros lists six steps countries should take as they are in lockdown mode: expand, train, and deploy health care workforce; create systems to find all suspected case at community levels; increase production and availability of testing; identify and equip facilities needed to treat and isolate patients; develop plans on how to quarantine contacts; and focus the whole government on the suppression and control of the pandemic.

"These measures are the best way to suppress and stop transmission, so that when restrictions are lifted, the virus doesn't resurge. The last thing any country needs is to open schools and businesses, only to be forced to close them again because of a resurgence," he says.

Saint Kitts and Nevis, Guinea-Bissau, British Virgin Islands, and Mali report first cases of COVID-19.

The US now has 80,000-plus deaths. But when it had 42,000 confirmed cases, as we did until the other day (they have increased since) have now, it had only 522 deaths compared to our nearly 900.
