

# Pakistan Society of Development Economists: Secretary's Report

On this occasion last year, I had reviewed the history, and aims and objectives of the Society. I had also outlined at some length the major activities undertaken by the Society since its inception. I feel no need to repeat what I had reported last year, especially because its account has been published in the 1985 Proceedings issue of the Pakistan Development Review. I would only submit that the Society, in the four short years since its creation, has grown from strength to strength and that by now it is a fully grown organization effectively achieving the objectives for which it was created. I am happy to report that the state of the Society is excellent with all-time records set this year in membership, in attendance at the Annual Meetings and in the breadth and scope of the issues addressed both in the Lecture Series in Development Economics and in the Annual Meetings. We now have a rich experience and a routine has been established which should be helpful in an efficient conduct of the activities of the Society in future years.

# Membership

The membership of the Society has reached an all-time high level. It stands at 441 on August 12, 1986. Table 1 shows the growth in the membership of the Society since its inception.

The size of the membership appears small in absolute terms. It is, however, quite high if evaluated as a proportion of the total stock of Pakistani economists and

of economists from other countries working on Pakistan's economy. Also, the growth in membership has been rapid. It has almost doubled since 1983. An healthy increase of 11 percent in the membership was registered during the current year.

## Lecture Series in Development Economics

The Lecture Series in Development Economics has made a steady progress. Professor Vernon W. Ruttan (University of Minnesota) and Professor Winfried von Urff (Technical University of Munich) delivered two lectures each in the general area of Agricultural Development during the current year. As always, the lectures were heavily attended by academics and policy-makers. The lectures along with the discussions that followed them are being processed for publication.

#### **Annual General Meeting**

In broad terms, the format and scope of the Third Annual General Meeting of the Society is similar to those of the previous two Meetings. There are some new features of the present Meeting which need to be noted, however. The number of papers to be presented and discussed is 35, which is much higher than the number of papers presented at either of the two previous Meetings. The number of contributors from outside Pakistan has increased over time. However, it is gratifying to know that the increase in the contributions from Pakistani social scientists has been relatively more pronounced. This healthy trend is largely due to the increased confidence of Pakistani scholars generated by the activities of the Society. The attendance at the Meetings has also shown a considerable increase. A small part of this increase is attributed to the increased membership of the Society. The more important factor behind the larger attendance is the increased willingness on the part of the members to participate more actively in the activities of the Society. The scope and range of issues discussed have also been widened. The role and status of women in Pakistan was the subject matter of an invited lecture. An audio-visual presentation of an action-oriented research project on urban slum development in Karachi by Dr Akhtar Hameed Khan was an entirely new type of contribution at the Meetings.

# Media Coverage

This year the dissemination of the work of the Society through the various media channels reached unprecedented heights. This included an extensive news coverage on national television, radio and the newspapers and in-depth interviews of the President and a large number of renowned invitees to the Annual General Meeting, on the functioning of the Society and their perception of current development issues. Radio Pakistan, in addition to presenting special daily summaries of the proceedings, put on an exclusive forty-five minute national hook-up programme on the Annual General Meeting.

#### **Directory of Economists**

A Directory of Pakistani Economists has been prepared. So far 546 economists have been listed in this Directory. Copies of the Directory are placed at the registration desk. I hope the members are pleased with both the format and content of the Directory. If there are any suggestions for improvement, please let us benefit from them as we intend to revise and expand the Directory. We intend to present the Directory to the Governing Council of the Society in its next meeting for approval before its release and publication.

I have no doubt in my mind that the management of the Society will take initiative in these areas and would always do much more than what the membership expects from it.
