

COMPETITIVE GRANTS PROGRAMME FOR POLICY-ORIENTED RESEARCH

Pakistan Institute of Development Economics, Islamabad (Progress for the month of July 2023 for the PIDE Monthly Newsletter)

RASTA is the largest economics and public policy research grants programme in Pakistan –establishing an extensive knowledge network – producing high-quality, evidence-based policy research informing Pakistan's public policy processes. Its network includes around 2,200+ researchers & academicians, 65+ universities, and 10+ international institutes.

The objectives of the RASTA program are to: (a) Reduce the research-policy gap by stimulating economic and social science research and debate across Pakistan; (b) Build a network to stimulate internally defined and produced policy-relevant research; (c) Provide a knowledge-sharing platform where different actors can present and share evidence-based research to inform decision-making in the government; (d) Revisit the future policy agenda in line with the evidence produced in this program; and (e) Build capacity and improve policymaking and implementation by involving and engaging local universities, think tanks, policymakers, practitioners, and other stakeholders. The programme is guided by the following 28 members Research Advisory Committee (RAC), chaired by the Vice-Chancellor, PIDE Islamabad.



The RASTA programme has two broad streams through which it is building research networks, funding research projects, and informing public policy in Pakistan: the Competitive Grants Programme (CGP) and the Demand-Driven Research (DDR). Under CGP, research proposals are invited on specific themes/topics decided by the Research Advisory Committee, followed by a rigorous three-stage double-blind review process and announcement of awards. DDR programme is a pro-active evidence-based research approach to inform governments' policy-making processes. The final output of CGP & DDR projects is in the form of books, research reports, journal articles and working papers and policy briefs.

TRAFFIC MANAGEMENT REPORT & HOUSING BOOK

RASTA and PIDE launched two much-awaited reports on "Power, Profit & Plans: The Political Economy of Housing in Pakistan" and "Traffic Management & Congestion Mitigation: Parking Policy for ICT". The publications are the final product of projects funded under the Demand-driven Stream of the RASTA.

The book and the report were launched at Wednesday 12th July 2023 at the P-Block Auditorium, M/o Planning Development & Special Initiatives, Islamabad. The highly anticipated gathering brought together esteemed experts, policymakers, and stakeholders to address the urgent challenges surrounding the housing sector in the country.



Dr. Nadeem UI Haque, Chairman RASTA /Vice-Chancellor PIDE, addressed the audience and highlighted key challenges and opportunities. Dr Nasir Javed, former CEO Urban Unit Punjab and lead author of the book, presented key features of the Power, Profits & Plans: Political Economy of Housing in Pakistan book. While commenting on the Housing book, Mr. Pervaiz Latif Qureshi, Urban Development Expert, said that the Book offered a number of policy, institutional, financing, and taxation reforms that were likely to improve housing affordability, especially for the middle and lower classes. Dr Idrees Khawaja, Former Chief of Research and lead author of the report, presented the key findings of the Traffic Management & Congestion Mitigation: Parking Policy for ICT Report. Commenting on the Traffic Report, Mr Amir Ali, Secretary BISP & Ex-chairman CDA, that the study emphasizes curbing car use rather than raising revenue. Reduction in car use is possible only if alternate means of transport are available; therefore, adequate alternate mobility means are vital to achieving traffic mitigation through paid Parking.

Dr. Faheem Jehangir, Director RASTA, wrapped up the session by providing the audience with valuable updates on the continuous accomplishments of RASTA.
