‡ An approach that helps people make informed decisions about policies, programmes and projects by placing the best available evidence at the heart of policy development and implementation

Evaluation can be useful to governments and others...

- ‡ To support policy making ² especially budget decision making ² performance budgeting, and national planning
- ‡ To help government ministries in their policy development, policy analysis and programme development
- ‡ To help government ministries and agencies manage activities at the sector, programme, and project levels
- ‡ To enhance transparency and support accountability relationships

- ‡ Strengthened knowledge management








‡ Supply side: Capacity to conduct good evaluations

- ‡ Independence of mind and integrity
- ‡ Knowledge and respect of evaluation standards
- ‡ Agreed evaluation processes and products
- **‡** Formal education
- **‡** Specialized training
- ‡ Professional conferences and meeting
- ‡ On the job training
- ‡ Community of practices and networking




Enabling environment

 - ‡ Results-based management and public budgeting
 - ‡ Transparency and accountability


‡ Strong civil society



Lessons in building national M&E systems

- ‡ Existence of an M&E driver (e.g. central leadership)
- **‡** Stewardship close to the centre
- ‡ Clarifying purpose of M&E information
- ‡ Incentives to use M&E information (e.g. civil society demand, evaluation associations, parliamentarians)
- ‡ Aligning with the national context
- ‡ Linkage with results-based management

Critical success factors

- ‡ Policy and organizational framework
- **‡** Values and ethics
- ‡ Infrastructure to use M&E information
- **‡** Oversight
- **‡** Sustainability



Key stakeholders

- ‡ Senior government official, e.g. Office of the PM (leadership)
- ‡ Central agency, e.g. Ministry of Planning (stewardship)
- ‡ Ministries (operationalization)
- ‡ Senior M&E committee (guidance)
- ‡ National statistical agency (expertise)
- ‡ National audit office (oversight)
- ‡ Parliamentarians (accountability)
- ‡ Civil society (advocacy)
- † Training institutions, academia (skills)
- ‡ Private sector (consolidation)
- ‡ Other non-public agencies (partnership)

What can governments do to strengthen the evidence agenda?

- ‡ Demonstrate the intrinsic value of evidence in the context of good governance
- ‡ Establish policies, systems, procedures, rules to encourage demand and supply of evidence
- ‡ Put in place a value framework that rewards transparency and evidence generation
- ‡ Build internal capacity to demand evaluation, and foster external capacity to supply evaluation
- ‡ Engage with non-government actors to strengthen quality and credibility

What can parliamentarians do to strengthen the evidence agenda?

- ‡ Demand rigorous evaluative evidence of the use of public funds
- ‡ Demand rigorous evaluative evidence in support of draft legislation
- ‡ Establish an evaluation policy for the government to set expectations, standards and norms for the evaluation of public sector programmes
- ‡Engage with regional and global SDUOLDPHQWDULDQV¶ QHWZRU and exchange practices

What can civil society (associations, youth groups, interest groups), press, academia, research institutions, etc. do to strengthen the evidence agenda?

- ‡ Demand rigorous evaluative evidence of the use of public funds
- ‡ Advocate for the establishment of transparent and rigorous national evaluation systems
- ‡ Generate and avail of opportunities for evaluation capacity development
- ‡ Create and participate in advocacy and learning forums
- ‡ Lead by example in demanding and using evaluative evidence in public policy advocacy and programming


