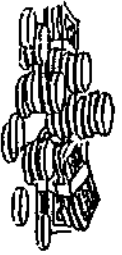

Business related consumption shall be excluded.

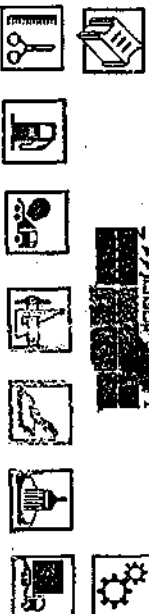
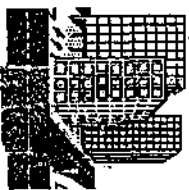
