TYPE OF OPEN COMPETITIVE BIDDING:

As per PPRA Rule, Single Stage, One Envelope -Bidding Procedure shall be followed. The said Procedure is reproduced as follows:

36. Procedures of open competitive bidding.-

Save as otherwise provided in these rules the following procedures shall be permissible for open competitive bidding, namely:-

(a) Single stage – one envelope procedure.
Each bid shall comprise one single envelope containing, separately, financial proposal and technical proposal (if any). All bids received shall be opened and evaluated in the manner prescribed in the bidding document.

TENDER PRICE & CURRENCY:

The quoted price shall be:

- Inclusive of all Government applicable taxes; and
- Denominated in Pak Rupees;

BID SECURITY:

The Bidder shall furnish the Bid Security (Earnest Money) with the Tender Document and the same should be upload on E-PADS, detail is as under:

Bidders applying for "Repair, Maintenance, Plaster and Rock Wall/Paint work at PIDE" to submit the Pay Order/Demand Draft as earnest money of amount Rs. 100,000/- as a bid security in favor of "Pakistan Institute of Development Economics, Islamabad".

OPENING OF THE TENDER:

PIDE shall open all bids through E-PADS at the time, date, and place specified in tender notice, in presence of bidders' representatives who wish to attend the meeting and shall sign an attendance sheet as evidence of their presence.

TERMS AND CONDITIONS:

The tenderers are required to fulfill the under mentioned conditions failing which the bid will not be accepted:

- The tenderers shall have to deposit earnest money in the form of Pay i. Order/Demand Draft only (Cheques are not acceptable) in favor of Pakistan Institute of Development Economics.
- The earnest money will remain with the PIDE till the completion of the work. It ii. shall be forfeited, if the firm fails to complete the work.
- Only registered suppliers, who are on Active Taxpayer List (ATL) of FBR, are iii. eligible.
- iv. The firms must have established office in Islamabad / Rawalpindi, which can be inspected by the Institute's Authorized Officer (if deem necessary).
- Over writing and cutting of any nature in quotation(s) shall not be accepted and v. the quotation shall stand cancelled.
- The participating firm (s) shall have to provide a copy of their PEC, G.S.T & NTN vi. registration certificate.
- The vender shall give an undertaking that his firm has not been blacklisted by any vii. of Provincial or Federal Government Departments, Agency, Organization or autonomous body etc. anywhere in Pakistan.
- viii. In case, the firm tries to sub-contract work, their contract shall be cancelled and earnest money shall be forfeited and the firm shall not claim any relief in this situation.

TENDER ELIGIBILITY/QUALIFICATION CRITERIA:

Eligible Bidder/Tenderer is a Bidder/Tenderer who:

- a. Must be registered with Tax Authorities, and having valid registration of Sales Tax and NTN & Pakistan Engineering Council (PEC) for civil work, and also having sound financial strengths can participate (copy must be attached);
- b. Has submitted bid and bid security and tender fee (nonrefundable). Noncompliance of the same shall cause rejection of the bid;
- c. Must be involved in relevant field for last 4 years (copy must be attached);
- d. At least 02 Previous reputation / work completion certificate and current working proof/reputation certificate. (Previous reputation shall be highly matter).
- e. Has not been blacklisted by any of Provincial or Federal Government Department, Agency, Organization or Autonomous body or Private Sector Organization anywhere in Pakistan (submission of undertaking on legal stamp paper is mandatory), failing which will cause rejection of the bid;
